PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

The company has carried out a wide range of projects and activities this year related to development, education and the mathematical sciences. During the financial year ending 31 January 2019 the companies activities have benefited the community in the follow way:

- Through offering research methods supports to agriculture research projects in West Africa, we are supporting these projects to improve access to local, sustainable, nutritious food through collaborative research and knowledge-sharing with smallholder famers, research institutions and development organisations. At the end of the year we initiated a project to establish an agroecology hub in Kenya. The hub aims to support local partners to develop the necessary structures that could enable them to support the wider farming community across East Africa through the use of effective agroecological approaches. These projects have an overarching aim to explore solutions for sustainable, local food systems to improve the lives of people in some of the poorest parts of the world.
- We have carried out activities supporting climate and climate change research and making it easier to access and use climate data and information. These activities include running workshops on the use of free satellite data for climate monitoring, supporting the Lesotho meteorological service to manage and analyse their climate data, helping to develop Climsoft: a free, climate database management software for use by national meteorological services around the world, developing free tools to analyse climatic data, and investigated ways of getting appropriate climate information for decision making to farmers in Kenya through financial service providers. These projects aim to improve understanding of climate and climate change among researchers, government organisations, farmers and others with the aim of supporting more informed decision making in adapting and tackling changes in climate.
- We have carried out activities to improve mathematical science education in Africa. We support the development of R-Instat, a free statistics software, which is used to improve statistics teaching in higher education in Kenya by making courses more practical and relevant for students. We began working with Maseno University, Kenya to develop electronic assessment to improve the learning experience of students in first year courses through automated feedback to support learning. We co-taught a statistical problem solving course to 47 MSc students in Cameroon.
- We have spent time supporting the African Maths Initiative (AMI), Kenya who are working to create a stronger mathematical community and culture of mathematics across Africa in all academic levels. Our support includes helping to build local capacity by mentoring their interns, supporting AMI in developing partnerships with Manor House Agricultural Centre and M-PESA Foundation Academy, delivered a training with AMI to volunteers going to work with students in schools across Kenya, and supported two members of AMI to deliver a workshop at a mathematics education conference.
- We have supported the charity Supporting African Mathematics Initiatives (SAMI) in:
 planning 'maths camps' that provide an inspiring, enjoyable mathematics experience to
 secondary school students across Africa, planning a London maths camp for UK
 students that also raises funds for SAMI, and attended SAMI theory of change and
 annual general meetings.

Our community is defined broadly, and in our first year we were keen to start serving the community in a focused way, as described in part 1. In the first year the company has actively engaged with selected stakeholders. We highlight the three main partners with whom we have engaged related to supporting our desired community. They are the UK charity SAMI to which we are asset linked to, the Kenyan NGO AMI and Maseno University, Kenya.

We attended SAMI's annual general meeting and discussions helped us better understand how the company could support them in improving mathematics education across Africa. We were involved in further meetings and planning of maths camps, in UK and Africa, contributing our experience to these events. Discussions and meetings with SAMI revealed that their major challenge in sustaining and expanding their education activities in Africa is having a steady income stream. A large effort of the charity is spent on fundraising. The company therefore has agreed to donate £9,000 from its first year surplus to SAMI to support its education activities and its financial support to AMI.

The company has held various meeting with AMI, both remotely and in Kenya, and the company has collaborated with AMI on a number of projects, as described in part 1. AMI requested support in mentoring its young team of 8-10 interns. During this year, the company invested time in providing mentorship, supporting the professional development of the AMI interns through electronic and face-to-face communication. This not only supports the individual interns, but also the activities they carry out for AMI, working with schools and teachers across Kenya and developing free software for teaching and learning in schools and universities. This aligns with the company's commitment to local capacity building.

Mathematics lecturers at Maseno University, Kenya requested support from the company to develop electronic assessment which would improve the feedback and learning opportunities for very large first year classes. The resources developed through this support will be openly available. Through the identification of this need by lecturers at Maseno University, in the following year, the company plans to support further universities in Kenya, and beyond, who face similar challenges and whose students would benefit from an improved education through using these resources.
